This two-day training will begin with a review of CPTED strategies to ensure participants share a basic comprehension of CPTED. Then, we will start understanding how CPTED may work in concert with processes for identifying and evaluating built-environment structures/facilities at risk for damage or loss due to human-made or natural disaster.

With an unstable World and evolving threats directed at our cities, every community must have individuals who can help determine what facilities/structures might be at greater risk, coupled with an ability to determine the potential impact if such locations would be damaged or destroyed.

We will consider Asset Value, Buffer Zone, Threats & Hazards, Vulnerability, and Risk. We will also attempt to clarify the difference between critical infrastructure targets vs. targets that might be more symbolic. Both carry common risks and potentially very different consequences in the case of damage or complete loss.

DAY-ONE:

The first training day will consist mainly of classroom activity and training.

We will spend a portion of our time reviewing best practices from both the public and private sectors and make some examples available to the participants.

DAY-TWO:

The second training day will consist of groups conducting actual assessments of a facility, preparation of a brief PowerPoint presentation to demonstrate their findings/observations. This will include a presentation to the class on their findings. This will be a learning opportunity and everyone will be encouraged to participate and to share their thoughts and observations.

CLASS NEEDS:

Students should ideally bring a laptop computer (if possible), a flashlight, digital or phone camera, and clothing to permit various indoor and outdoor activities.

INSTRUCTORS:

Throughout Ohio and the US, OCPA's instructors are well-known and active in their profession with multiple years of expertise in law enforcement, crime prevention, and private sector security. All of the instructors for this course are OCPA Certified Prevention Specialists (CPS), and the Senior Instructor is ICPS and NCPS II certified.
