Marshall Freeman is the Deputy Chief Administrative Officer of the Atlanta Police Department. Prior to joining the APD, Marshall served as the Chief Operating

Officer for the Atlanta Police Foundation, the nationally renowned non-profit law enforcement advocacy, strategic planning and research organization that supports public safety in Atlanta. He led a team that manages programs and initiatives designed to prevent and decrease crime, enhance public safety infrastructure, increase police visibility, provide midcareer training to Atlanta Police Department officers, and test and acquire state-of-the-art technology for the south's largest urban police force.

A native of Detroit, Marshall is a graduate of Johnson & Wales University, where he earned a Bachelor of Science Degree in Sports/Entertainment and Event Management. Marshall is a member of the International Association of Chiefs of Police. He is also involved in several civic roles: Crime Stoppers USA, Regional Director; Inspire Brands Foundation, Trustee; Midtown Atlanta Rotary Club, Member and serves on the LGBTQ Advisory Board for the City of Atlanta.

### Ohio Homeland Security and the Ohio Fusion Center Network

State and major urban area fusion centers serve as focal points to integrate information from local, state, federal, public and private sectors, creating information and intelligence products which target known or emerging threats and vulnerabilities. Analysts at the centers evaluate information from multiple sources and subsequently develop intelligence and informational products to aid first responders and other partners to ensure public safety. These informational and intelligence products are distributed not from a single viewpoint but from a comprehensive and neutral homeland security perspective. The centers work with an extensive network of partners endeavoring to prevent rather than respond to a critical incident. The Ohio Fusion Center Network is comprised of three centers which are all recognized by the US Department of Homeland Security. The Northeast Ohio Regional Fusion Center (NEORFC), Greater Cincinnati Fusion Center (GCFC), and Statewide Terrorism Analysis and Crime Center (STACC), through their partnership, offer unique services that can be leveraged by first responders across the state.



Michael Herb is the Director of the Northeast Ohio Regional Fusion Center (NEORFC). He oversees a team of analysts, manages the day-to-day operations, and directs the overall mission of the center to service the local, state, and federal partners in northeast Ohio. Current collaborations and projects examine issues in gun violence, the opioid epidemic, and domestic violent extremism. Prior to taking over at the NEORFC in 2019, he served as an administrator with the Cuyahoga County Sheriff's Department where he worked to create and implement an information sharing platform to connect over 60 law enforcement agencies in the county. Before his work in Ohio, he was a full-time police officer with the Houston (TX) Police Department. Director Herb holds a Bachelor of Science in Criminal Justice and a Master of Science in Science, Technology, and Public Policy from the Rochester Institute of Technology in Rochester, New York.



Janille Stearmer has served as Assistant Director of Ohio Homeland Security since July 2021 and was appointed as the Acting Executive Director on August 10, 2022. Within the scope of her duties, Ms. Stearmer is engaged in developing statewide homeland security and manages all units in the division; Private Investigator Security Guard Services (PISGS), Infrastructure/Cybersecurity Protection, Education and Outreach, Planning and Grants, and the Terrorism Analysis Unit (TAU) at the Statewide Terrorism Analysis and Crime Center (STACC).

Ms. Stearmer holds a Master's degree in Public Administration and Geographic Information Systems and two Bachelor's degrees. She is also

a graduate of the Emergence Program through the Center for Homeland Defense and Security at the Naval Postgraduate School.

Over her 16-year career in public safety, Ms. Stearmer has spent considerable time supporting community-level public safety programs including Citizen Police Academies, Community Emergency Response Teams (CERT), and first responder Rescue Task Force training. Prior to her career in public service, Ms. Stearmer managed a business with her husband while raising four children.

Lieutenant Jennifer Mitsch is a twenty-five-year veteran of the Cincinnati Police Department. Lt. Mitsch has served in Patrol, Violent Crimes, Personal Crimes, Homicide, and Planning Section prior to her assignment as the Director of the Greater Cincinnati Fusion Center & Real Time Crime Center in January of 2022. She was responsible for the creation and development of the Cincinnati Citizens Respect Our Witnesses (CCROW) program and oversees numerous Department projects such as ShotSpotter and Grants Administration. Lt. Mitsch has a Doctor of Education in Leadership Development and Master of Science in Human Resource Development, both from Xavier University.



### Transcend Robotics & Brinc Drones Demonstration

Transcend Robotics delivers robots that never give up. Through relentless innovation and fueled by operator feedback, Transcend has successfully delivered hundreds of robots to law enforcement and militaries worldwide. The technology enables robotics systems to move freely in unpredictable environments for reconnaissance, bomb and hazardous missions. EDGE SWAT will provide a demonstration of the Vantage Robot and BRINC drones.

EDGE SWAT is a multi-jurisdictional team comprised of members from six (6) city police departments: Euclid, South Euclid, University Heights, Cleveland Heights, Shaker Heights and Beachwood. The team consists of 35 SWAT operators, 12 Crisis Negotiators Team (CNT), 9 SWAT medics, 3 SWAT Canines, 4 Marksman/Observers and 5 Bomb Technicians.



### Columbus Therapy Dog Unit

Officer Paulins is the handler and head training for the Columbus Therapy Unit which he started in 2019. Learn how this unit was formed and how the TDU is used throughout the department and community, as well as the training the dogs undergo.



Officer Mike Paulins, pictured with Simon, is a graduate of Ohio University and the National K-9's Master K-9 School. Mike has been with the Columbus Police Department since 1993 and spent15 years as a Detective in Special Victims Unit before forming the Therapy Dog Unit in 2019.

### **Community Response Unit**

CRU focuses a small team of officers to address specific problems in targeted hotspots for issues primarily related to illegal firearms and narcotics possession. CRU is not assigned to radio calls but saturates areas in the community that are known for high levels of criminal activity, CRU officers use a



proactive policing style that engages community members in solving problems in micro locations. Utilizing a diverse style of policing by wearing fully-marked uniforms and plain clothes for surveillance, the CRU assists narcotics and the detective bureaus to develop felony cases, address juvenile concerns, and other quality of life issues.

Euclid Police CRU consists of Sgt. Shon Williams, Officer Matt Gilmer, Officer Sam Thirion and Officer Brandon Moore with a combined 37 years of law enforcement experience. The CRU has led the department in gun seizures, 134 firearms in 2022, and \$84,000 in US currency seizures for narcotics investigations.

### Community Engagement in Rural Communities – Staying Connected with Program and Technology

Union County Sherriff's Office engages with the rural community through programs, technology and fundraising. Learn how to run successful initiatives such as Project Life Saver, Senior Watch, Neighborhood and Business Watch, CRASE training in the workplace and House of Worship, Coffee with the Sheriff and Deputies, Safety Town and crime prevention outreach initiatives for farm safety. The UCSO




also utilizes Kind Calls for Seniors and a Sheriff's app to connect with residents, and has successfully operated fundraisers to bring in thousands of dollars!

Union County Sheriff Jamie Patton is President of the Buckeye Sheriff Association and has over 30 years of service to the citizens of Union County that includes corrections, patrol, investigations, juvenile, property and sheriff responsibilities. He is a member of FOB Lodge 171, Union County Farm Bureau, and a board member of the Union County Public Safety Support Group.



Deputy Rich Crabtree has been a deputy for Union County since 2000 and became the Public Safety Officer in 2001. He is cross-trained to be an emergency medical technician and firefighter, and he a crisis negotiator. Deputy Crabtree is the SRO and crime prevention officer who focuses on promoting citizen awareness of crime prevention methods.

Huber Heights Police Division went from an average police department to crushing it! HHPD has three very active social media platforms and a website, and offers residents a Citizens Police Academy, Crime Prevention Academy, and a variety of awesome events.

Developing relationships with the community is an integral part of police work and the department has used community help to acquire resources and execute successful events. Learn from Officer Nick Lambert how to crush it in your own community.



Nick Lambert is a combat veteran and served in the United Stated Air Force. Officer Lambert started in law enforcement in 2006 working at the Miami County Jail, graduated from the Sinclair Police Academy and started working for the Huber Heights Police Division in 2009. Officer Lambert's duties have included working patrol, school resource officer, field training officer, honor guard, and officer in charge. Currently, Officer Lambert is Huber Heights Police Public Affairs Officer, a role he loves and he's crushing it!

### 8-80 Cities

Transforming communities into spaces that can support everyone from ages 8-80 creates a sustainable city with welcoming and accessible spaces; a city for people to grow up and grow old; where all people have the right to safe and active mobility. Officer Dunn will cover how police can achieve a safer community through engagement using the principles of 8-80.

**Officer Martin Dunn** is the Community Relations Officer (CRO) /Crime Prevention Specialist (through the Ohio Crime Prevention Association - OCPA) for the Shaker Heights Police Department in Cuyahoga



County. Officer Dunn is a part of the Community Engagement Unit for the Police Department which is assigned to the Detective Bureau in the Police Department. His duties include creating school-related safety programs for students, supervision of school crossing guards, conducting premises security inspections for residential homes and business and developing community-based educational and engagement opportunities in the City of Shaker Heights. He is in his 27<sup>th</sup> year as a Police Officer and has been with the Shaker Heights Police Department since 2007. He had worked for the East Cleveland Police Department 12 years prior to coming to the SHPD and is a Persian Gulf/Desert Storm Veteran.

### From Active Threat to Threat Assessment, Empowering the OSU Community

Campus safety is priority for The Ohio State University Police Department and is ever evolving. The OSU campus is over 2.5 square miles with five extension campuses and property in all 88 counties in the State of Ohio. A student population of 65,000, staff population of 47,600, Wexner Medical Center staff and patients, and numerous campus visitors daily creates unique challenges for OSUPD. Detective Shaffer will share how a large campus like OSU employs active threat and threat assessment programming for civilians and how the department engages and empowers the community. This presentation will provide insight into how safety on a campus this size is achieved through a partnership with Buckeye Nation. Detective Shaffer encourages anyone to ask questions about the department's challenges and accomplishments in this goal.



Detective Cassandra Shaffer has been an officer with The Ohio State University Police Division for 14 years. From night watch officer to Joint Patrol Unit, Detective Shaffer was also selected for the investigations bureau and eventually assigned to focus on threat assessment and crisis cases that affect the university community. Detective Shaffer is the primary crime prevention officer and assigned as the LEO liaison to the Office of the President, Academic Affairs, Compliance, Legal Affairs, and other university stakeholders. Detective Shaffer serves on both threat assessment teams for Student Life and Human Resources. She is a member of the Association of Threat Assessment Professionals and a master trainer through Homeland Securities National Threat Evaluation & Recognition program, and serves on the Dignitary and Defensive Tactics teams and is assigned as the primary officer for the university president.

personal goals as this session will explore the best sales methods to improve communication skills.





### Presentation: Locating, Legally Obtaining & Utilizing Digital Evidence

Review a case study involving a premeditated home invasion which resulted in the homicide of the targeted resident and subsequent arrest and prosecution of three responsible suspects. The complex nature of the investigation utilized multiple facets of digital evidence collection and review culminating in a successful conclusion to the investigation.



Mike Knack is a thirty year law enforcement veteran, retired from the City of Euclid who has served in detective bureau, administrative services, community policing, and patrol platoons. Mike has a bachelor's degree and over 3, 230 hours of continuting education and certification in law enforcement, crime prevention, emergency repsonese, and leadership. Security Surveys LLC and works with large and small businesses, schools and places of faith on violence prevention and security awareness.

### Protect the Nation's Transportation Systems to Ensure Freedom of Movement for People and Commerce

TSA Surface Inspectors are responsible for some regulatory inspections, but the primary focus is within the TSA Outreach Programs which are free to any business where land-based transportation is a function of the business. These programs are designed to help elevate awareness and decrease opportunities for risks related to terrorism or other criminal activities. Crime prevention practitioners will learn how the TSA Outreach Programs help businesses in training, assessing processes, evaluating security programs,





Jeri Roper is a Surface Inspector for the TSA and she performs outreach programs for all land-based transportation in Northern Ohio. Surface inspectors work with freight rail, passenger rail, mass transit, passenger buses, school districts, trucking, and other critical transportation infrastructure.

### Protecting Older Ohioans from Investment Fraud

Older adults are especially vulnerable to financial fraud, and their families are often financially impacted if the person loses his or her entire savings. Presenters will provide an overview of the elements of investment fraud, a felony level crime in Ohio, an overview of the resources available to help protect Ohioans from becoming a victim, as well as resources to help identify and prosecute investment fraud.



Janice Hitzeman is the Attorney Inspector and Chief of the Enforcement Section for the Ohio Division of Securities. Prior to joining the Division in 2010, Janice worked in the Fraud Division of the Ohio Department of Insurance and was an Assistant Prosecuting Attorney with the Delaware County Prosecutor's Office in the Felony Criminal Division. Prior to joining the law enforcement community, she was in private practice for 10 years, focusing on real estate, mortgage lending, and title insurance law.



**Leo Fernandez** is a certified public accountant licensed by the Ohio Board of Accountancy. His background for the last 20 years in public service includes positions as a forensic accountant and a fraud auditor for the Ohio Attorney General's Office and the Ohio Auditor of State's Office, respectively.



Joe Vance is currently a Magistrate in the Summit County Court of Common Pleas. Before moving to the court, he was a career Assistant Prosecuting Attorney. ### Ohio State Highway Patrol Criminal Intelligence Unit - Capabilities Overview



The presentation will provide an overview of the Ohio State Highway Patrol's Criminal Intelligence Unit's capabilities. The presentation will focus on how the unit can provide real-time assistance, case support and products for both internal and external law enforcement customers.

The Ohio State Highway Patrol Criminal Intelligence Unit was established in 2002, becoming fully staffed and operational in 2012. The Intelligence Unit currently provides 24/7 support to internal and external law enforcement customers with real-time crash, case and traffic stop assistance, as well as long-term, larger scale case support. OSHP Intelligence Analysts are trained in a number of disciplines and provide analytical support for a wide variety of

criminal activities. Services are offered free of charge to any inquiring law enforcement agency. This workshop for sworn law enforcement officers only.

### **Operation Identification: The Forgotten Crime Prevention Tactic**

While security cameras, alarm systems, video doorbells and geo-locators are popular among consumers, law enforcement professionals only endorse Operation Identification. Operation ID provides the critical information needed to solve, arrest and convict criminals—the owner-applied number (OAN), make, model and serial numbers of stolen, lost and missing property—all of which is easily uploaded to the National Crime Information Center (NCIC).



Jon Shelness is a subject-matter expert on Operation Identification and has developed a police-accepted enhancement of Operation ID at MPIDR.com. Jon has a criminal justice background and has been a board member of his neighborhood association in Des Moines, Iowa,

since 2013. Operation ID has been presented to: California Crime Prevention Officers Association, Florida Crime Prevention Association, and Western States Rural Livestock Enforcement Association.



### Police Activities League and Faith Outreach Programs

Designed with the specific purpose to connect with their community and make positive impacts on their youth, PAL Programs in Euclid continue to find great success. Driven by the efforts and energy of a key team of people, the non-profit arm of Euclid Police uses programs like soccer camps, basketball, Safety Town, and the Junior Police Academy to bridge gaps with the youth and continue to fight the sometimes-negative perception of law enforcement. Also, learn how Euclid Police are continuing to build

relationships with their houses of worship in an effort to better serve and connect with their community.



Officer George Panagiotou brings a unique perspective to his role as Community Policing Officer for the Euclid Police Department (EPD). After serving 14 years as an Infantryman in the United States Marine Corps, George felt the calling to serve in a different way - as a Police Officer. ### Police, Courts and Communities: Managing Problem Properties through Abatements

Police, city attorneys and communities often have options through the criminal justice system in handling problem properties. Complaints of continuous crime activity that include narcotics, prostitution and assaults can be handled as a nuisance abatement case which causes a private property owner to act or end up in court. Learn how the nuisance abatement process can be a force multiplier for your department.



Officer Chris Riley is currently assigned to the Organized Crime Bureau as a Nuisance Abatement Detective within the Columbus Division of Police. After serving over two decades as a Community Liaison Officer, Chris continued working in a position with direct community impact through a collaboration with the Columbus City Attorney's Office.

In addition to patrol, Chris' other auxiliary assignments within the police division includes time in the counter terrorism unit and as a relief flight officer. Detective Riley is an OPOTA SME and consults on matters of security and crime prevention. He has been a presenter for the National Crime Prevention Council in Washington DC, the Ohio Crime Prevention Association and serves as an adjunct instructor for the Central Ohio Technical College in Newark.



Steve Dunbar is an Assistant City Attorney in Columbus City Attorney Zach Klein's office. Steve is the Section Chief of the City Attorney's Zone Initiative Team, which works closely with the Division of Police, Code Enforcement, other city departments and community organizations to abate nuisance properties that blight Columbus's neighborhoods.

Steve has worked in the Columbus City Attorney's Police Legal Advisor Section and the Prosecution Section. Steve has also served as a Special Assistant United States Attorney prosecuting federal gun cases in the Southern District of Ohio. Prior to joining the Columbus City Attorney's Office, Steve was an Assistant Law Director in Marysville, Ohio, where he was also in private practice.

This presentation will discuss how to plan a termination in advance; how to identify high risk terminations and include a threat assessment process; how to use timing to your benefit; how to notify the employee; how to create soft landings; how to manage the logistics of termination meetings; and how to conduct follow-up actions if

Ohio Traffic Incident Management (OTIM) This statewide program looks to provide training to first responders on how to safely manage incident scenes. Learn about the trainings ODOT offers and many other aspects of the program.

ODOT Traffic Management Center (TMC) An overview of ODOT's traffic management center will be provided and how it can be used as a resource for officers responding to incident scenes. The center has access to over 1000 freeway cameras in the state and manages over 150 Digital messages boards. Learn about the TRIP Program (Towing & Recovery Incentive), Freeway Service Patrol Program, and ODOT's ability to record video from cameras, as well as the newly adopted wireless emergency alert

system and how Ohio's traveler information system (OHGO) is integrated.



Justin Yoh has been with the Ohio Department of Transportation for 14 years having spent the majority of his career working in ODOT's District 7, Dayton Metropolitan area as a Traffic Operations Engineer. Currently, Justin oversees ODOT's Transportation System Management & Operations and Traffic Incident Management programs. Justin holds a bachelor's degree in Civil Engineering from Ohio Northern University and is a licensed Professional Engineer in the State of Ohio.



Michael McNeill has been a member of the Ohio Department of Transportation for the past 13 years. After spending 10 years in the ODOT Highway Safety Program analyzing crash data & trends, Mike is now in the office of Traffic Management and oversees ODOT's Traffic Management Center, Freeway Service Patrol Program, other Traffic Incident Management Programs. Mr. McNeill earned his bachelor's degree in Civil Engineering from the University of Toledo and is a licensed Professional Engineer in Ohio.

### Westlake Police Drone Unit

Westlake Police use drones for both enforcement efforts, but also for community outreach such as crime prevention analysis for residential and business security surveys. Westlake PD will explain how their



drones offered critical information during an incident where the suspect fired at officers causing injury, but resulting in the suspect's apprehension. Two drones will be demonstrated during the workshop.

### **ADVANCED CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN** (CPTED)

Crime Prevention Through Environmental Design strategies consider architectural design of both the built and natural environments and can be employed to deter crime, reduce victimization, and build a better sense of community. CPTED includes analysis of access control, natural surveillance, territorial reinforcement, physical maintenance, order maintenance, and activity support. Facility assessment requires examination of designation, definition, and design while also considering asset value, buffer zone, threat and hazards, vulnerability and risk.

### **Course Content:**

Day one provides classroom training reviewing best practices for on-site CPTED assessments and identifying and evaluating the built-environment for risk of damage or loss due to crime or natural disaster. The difference between critical infrastructure targets and symbolic targets will be studied to evaluate consequences of damage or loss.

Day two provides group field work conducting a CPTED assessment and analysis of an actual facility. Groups will prepare a slide show presentation to demonstrate their observations and findings. Class discussion on presentations encouraged.
